I hereby agree to breed my mare _____ Reg. No. _____ to the
stallion VELLHOS BLUE PRIZE Reg. No. 3104496 for the 20__ season at \$ _____.
Of this amount a non - refundable booking fee of \$ _____ is payable with this contract. The
balance of the breeding fee will be paid when the mare is picked up. All other expenses
including board, vet expenses, foot care, if necessary, etc., will be due monthly. All bills must be
paid when the mare departs.

Note: No re breeding privilege will be honored unless the below conditions are met.

1. Live foal guaranteed with return privilege in season. It is understood that should the foal not stand up and nurse I will be entitled to a return privilege. This guarantee applies only if I notify you within one (1) week from death of foal. This notice must be accompanied by a statement from a licensed veterinarian. If the mare is to be returned and the owner of the mare fails to deliver her for re breeding the following year, then, any and all fees will not be refundable and this contract is thereby canceled.
2. Diligent effort will be made to settle my mare; however, if for any reasons she does not settle, I will not hold the stallion owner or his representatives liable nor will I be charged breeding fee, only mare care and booking fee.
3. Mare may not be removed from Breeder's possession until all expenses are paid in full.
4. It is further understood that should the above named stallion die, or become unfit for service, or, if the mare dies, or becomes unfit to breed, this contract becomes null and void.
5. A "Breeder's Certificate" will be issued when all fees are paid and my mare is vet checked in foal.
6. The mare's registration certificate or a photostatic copy of the front and back of the certificate must be furnished.

7. The mare will be in healthy and sound breeding condition, free from contagious or transmissible disease. Worming and immunizations must be current. Breeder reserves the right to refuse any mare. If mare is refused, the booking fee and mare care will constitute liquidated damages.

8. Breeder assumes responsibility for arranging veterinarian and farrier services as necessary (a) *Breeders*, (b) *Mare Owners* veterinarian will administer medical care as deemed necessary for the health and safety of the mare and / or foal. All veterinarian and farrier expenses will be paid by Mare Owner.

9. Mares must be halter broken.

10. Mares must be without back shoes.

11. I understand and agree that Elkhorn Quarter Horses and its representatives will not be responsible for accidents, sickness, or death to my mare or foal.

12. When a representative of Elkhorn Quarter Horses signs and returns one copy of this contract to me, it will then be a binding contract on both parties, subject to the above terms and conditions. This contract is not transferable.

13. This contract represents the entire agreement between the parties. No other agreement or promises, verbal or implied, are included unless specifically stated in the written contract.
